Balance is due upon arrival. Balance may be paid via cash or credit card, **no checks will be accepted.**

ELECTRIC & ADAPTERS	\$6.00/per day - Available electric: 30, 30/30 and 50 amp Adapters are available, but NOT GUARANTEED. A \$50.00 deposit and a copy of driver's license will be required to use MAMM adapters.
POOL PASSES	Transient dockage includes four (4) pool passes per boat, per transient stay Additional passes will be charged \$7.00/per person per transient stay
HOURLY STAY	\$1.50 per foot LOA for Day Stay includes use of bathroom facilities and Pool Passes for the day.
CANCELLATION	Customer must give 48 hour notice to cancel, otherwise forfeit ability to apply deposit to another date (based on availability) <u>within the 2012 season</u>. Deposits, which are non-refundable, may be transferred to another date (based on availability) <u>within the 2012 season</u>. Must give 72 hour notice for holiday cancellation i.e. Memorial Day, Strawberry Festival, Fourth of July, & Labor Day otherwise forfeit ability to apply deposit to another date (based on availability) <u>within the 2012 season</u>
CHECK OUT TIME	11:00 AM, boats staying longer will be charged accordingly

MARINA POLICY

1. The Owner shall agree to have the watercraft covered by a full marine insurance package (hull coverage as well as indemnity and liability coverage). We assume no liability for vandalism, theft, collision, fire, high or low water, wind, ice, rain or acts of God, or damage of any kind except when directly attributed to our own negligence, and in that event only to the extent of the retail used boat value of the boat on the date of loss. In case of damage, the boat owner must demand repairs before the boat is removed from the premises, and on demand MAMM is entitled to make or order repairs of the boat if it so chooses. In no event shall liability extend to payment for loss of use of a boat, or for loss of any articles left in the boat.
2. Groups SHOULD reserve their dates at least ninety days in advance and payments received sixty days in advance, otherwise space cannot be guaranteed.
3. Owner/boat operator is responsible for keeping the immediate area around boat in clean condition, and must use every precaution to prevent fire or accidents. Transfer of fuel at dock slips is prohibited. Matt-A-Mar Marina is environmentally friendly and we ask that our customers please sort their trash and recyclables and dispose of in designated areas only.
4. Dock boxes are not allowed on docks. BBQ's are not permitted on boats or docks. Please consult marina staff for directions to proper areas.
5. Overboard discharge of fuel, oil, waste or garbage is prohibited. Any boat found discharging fuel/oil will be hauled and Owner will be notified and billed accordingly.
6. Owner shall be responsible for damage, which they or their guests cause to other boats or any structure within the Marina limits.
7. No outside labor will be allowed unless authorized by management. Service by specialists must be arranged and billed through the Marina office.
8. All work below the water line must be performed by MAMM. All bottom work supplied through MAMM is in accordance with United States Environmental Protection Agency and New York State Department of Environmental Conservation regulations and standards.
9. Boats not properly secured will be re-secured without any liability to MAMM. Owner will be charged for equipment and time. This may apply during inclement weather or threat of inclement weather.
10. Children under the age of 18 are not permitted to sleep aboard without adult or guardian present. Living aboard any boat is prohibited from October 15 through April 15.
11. All pets must be leashed. Please clean up after your pet.
12. Please respect your neighbor and fellow patrons. Violations of the terms of this contract, disorderly or inappropriate conduct will result in the cancellation of this contract and forfeiture of all fees paid and expulsion of the customer and boat from the Marina.
13. It is recommended that shoes be worn at all times when walking on the marina property.
14. Returned checks will be charged a \$50.00 returned check fee.
15. This contract shall be deemed to have been made in the County of Suffolk and shall be construed in accordance with the laws of the State of New York. All actions or proceedings relating to this contract, directly or indirectly, shall be litigated only in courts located within the County of Suffolk in the State of New York.

I understand that swimming and boating activities can be hazardous activities. The undersigned hereby releases, waives, discharges, and covenants not to sue the owners, operators or members of Matt-A-Mar Marina Limited Liability Company or the owners and lessees of premises all for the purposes herein referred to as "releasees," from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of or related to boating and/or swimming activities, whether caused by the negligence [excepting the willful or gross negligence] of the releasees or otherwise.

I hereby agree to indemnify and save and hold harmless the releasees and each of them from any loss, liability, damage, or cost they may incur arising out of or related to boating or swimming activities whether caused by the negligence [excepting the willful or gross negligence] of the releasees or otherwise.

I hereby assume full responsibility for any risk of bodily injury, death or property damage arising out of or related to the event(s) whether caused by the negligence of releasees or otherwise. I affix my signature hereto and I accept the terms and conditions as provided in this three (3) page contract.

I HAVE READ, ACKNOWLEDGED AND I AGREE TO THE TERMS AND CONDITIONS CONTAINED IN THIS THREE (3) PAGE CONTRACT.

THIS CONTRACT CANNOT BE CHANGED IN ANY WAY EXCEPT IN WRITING SIGNED BY THE PARTIES.
