RULES & REGULATIONS

Violations may result in loss of Membership. **No refunds.**

This pool is licensed and operated in compliance with Suffolk County Department of Health Services Rules and Regulations.

1. Proper bathing suits must be worn, no cut-offs please.
2. No toys or foreign objects allowed in pool. ONLY POOL APPROVED TOYS
3. No food/beverage or glass allowed in pool area. Food and beverage are restricted to designated fenced area adjacent to pool
4. Membership pass and/or guest pass **must** be presented for access to pool.
5. Membership passes are non-transferable. A \$20.00 fee will be charged for a replacement pass.
6. Guests must be accompanied by a member, and purchase pass prior to entering pool.
7. Marina reserves the right to limit number of guests.
8. All members and their guests must comply with posted rules and regulations
9. Children under 16 years of age must be accompanied by and be under the constant supervision of an adult member
10. Marina is not responsible for breakdown in equipment resulting in pool closure due to force majeure, vandalism, or mechanical failure beyond operator's control. No refund will be issued.
11. Only Coast Guard approved life preservers only are permitted as per Suffolk County Department of Health Services.
12. Infants and toddlers must wear plastic cover over diapers or pampers.
13. If pool is closed due to weather conditions, no refunds will be issued.
14. Parents are completely responsible for their children's conduct and behavior. Children may be asked to leave the pool area after three (3) warnings from the Lifeguard on duty.
